

YMCA 'Spring Reset Challenge' - TERMS AND CONDITIONS (Terms)

1. OFFER AND ELIGIBILITY

- a. This 'Spring Reset Challenge' promotion (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is available at Gippsland Regional Aquatic Centre, South Gippsland Splash and Warragul Leisure Centre. (**Participating Centres**) between the dates of 5 October 2026 to 29 November 2026 (**Promotion Period**).
- d. To be eligible for the Promotion, participants must:
 1. Be an existing Health and Wellness member at a relevant Participating Centre during the Promotion Period
 2. Be aged 18 years or over; and
 3. Comply with these Terms and Conditions.
- e. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.
