

YMCA 'HALF-PRICE OFF-PEAK SWIM' PROMOTION - TERMS AND CONDITIONS (Terms)

1. OFFER AND ELIGIBILITY

- (1) This '**Half-Price Off Peak Swim**' promotion (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- (2) By participating in the Promotion, you agree to be bound by these Terms.
- (3) The Promotion is available at Latrobe Leisure Facilities including Gippsland Regional Aquatic Centre (**Participating Centres**) between the dates of **13 July 2026** and **31 July 2026** (**Promotion Period**).
- (4) To be eligible for the Promotion:
 - a. you must purchase a recreational adult swim entry at the Participating Centre during off-peak hours, being Monday to Friday between 11:00am and 3:00pm within the Promotion Period; and
 - b. the Promotion is available to casual users, including non-members.

For the avoidance of doubt, the Promotion applies only to adult recreational swim entry and does not apply to swimming lessons, gymnastics, water slides or other program memberships.

- (5) The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

2. OFFER TERMS

- (1) If you meet the criteria set out in clauses 1(4) and 1(5) above, we will provide a half-price off-peak recreational swim, being a 50% discount on the standard adult swim entry.
- (2) The Promotion includes complimentary access to the sauna, steam and spa facilities at the Participating Centre as part of the eligible recreational swim entry.
- (3) The Promotion does not include entry to the water slides. Water slide entry is excluded, and any applicable water slide charges will be payable separately in accordance with the Participating Centre's standard pricing.
- (4) All other applicable fees and charges in respect of facilities or services not covered by the Promotion will be payable in accordance with the Participating Centre's standard terms and pricing.
- (5) The Promotion is only available at the Participating Centre.

3. PRIVACY

4. MISCELLANEOUS

- (1) YMCA reserves the right to amend, cease and / or revoke the Promotion prior to the end of the Promotion Period in its sole discretion and without notice.
- (2) To the extent permitted by law, YMCA will not be liable to any person for any cost, loss, damage, liability, expense or claim arising, whether directly or indirectly, in connection with the Promotion.
- (3) Any dispute or situation not covered by these terms, will be resolved by YMCA management in a manner it deems to be fair (acting reasonably).
- (4) These Terms are governed by the laws of Victoria, Australia.
- (5) Members will be bound by their terms of membership with YMCA. To the extent of any inconsistency between the terms of membership and these Terms, these Terms will take priority.
